RENTAL POLICIES

1. This rental agreement stating **SUBLIME LIGHTING LLC**'s rental policies must be signed by an authorized representative of the renting company and returned to **SUBLIME LIGHTING LLC** prior to, or at the time of the pick-up, along with all required insurance documentation.
2. Equipment rentals are good for agreed upon calendar dates only. Unauthorized extensions beyond the agreed upon dates will be charged a daily rate.
3. There will be no allowance made for unused equipment.
4. The customer has the privilege to examine and test equipment at the time of the rental. **SUBLIME LIGHTING LLC** does not guarantee, assume responsibility, or make representations for the performance of the rented equipment.
5. Cancellations within twenty four (24) hours of the rental period will incur forfeiture of deposit.

TERMS

1. Payment of balance due is expected at the end of the rental period except if prior approval is arranged and agreed upon by **SUBLIME LIGHTING LLC**.
2. We accept checks, cashier's checks, money orders, and cash. There will be a fifty (\$50) dollar charge for all returned checks.

INSURANCE REQUIREMENTS

1. Customer must insure all equipment rented for the current replacement value before it can leave our premises.
2. Prior to rental, customer must provide an original Certificate of Insurance naming **SUBLIME LIGHTING LLC** as Additional Insured/Additional Loss Payee.
3. Customer must at their own expense, provide a minimum of one million (\$1,000,000) dollars of Comprehensive General Liability Insurance (including but not limited to, liability for bodily injury and personal injury insurance) with **SUBLIME LIGHTING LLC** named as additionally insured and provide written proof of thereof coverage.
4. Customer must at their own expense, provide Workers Compensation Insurance with at least a five hundred thousand (\$500,000) dollar policy limit.
5. Customer agrees that above said policies shall provide primary coverage in relation to any and all other contributing insurance coverage.

SUBLIME LIGHTING LLC

LOST AND DAMAGED EQUIPMENT

1. Customer is responsible for any damage to equipment other than normal wear and tear, which is to be determined by **SUBLIME LIGHTING LLC**.
2. In the event the rented equipment is lost, stolen, or damaged beyond repair, customer shall immediately pay **SUBLIME LIGHTING LLC** the current replacement cost plus any shipping and taxes when applicable.
3. Customer is responsible for all loss and/or damages to the equipment from the time it leaves our facility, until the time it arrives back to our facility, unless **SUBLIME LIGHTING LLC** has been contracted to provide delivery services.
4. Acceptance of the returned rented equipment does not waive claims against customer for latent or hidden damage to equipment.
5. Customer is responsible for loss of rental income while equipment is being repaired or replaced. At no time will rental charges be applied towards the purchase of equipment.
6. Customer shall notify **SUBLIME LIGHTING LLC** promptly of any accident involving the rented equipment.

SUBLEASE

1. Customer shall not sublease, rent, or loan **SUBLIME LIGHTING LLC**'s equipment to any other person, company, or entity.
2. Customer must remain in the immediate exclusive control, supervision, and direction of the equipment at all times.

WARRANTY

1. **SUBLIME LIGHTING LLC** is not responsible for any loss resulting from use of the equipment.
2. Equipment is used at the customer's sole risk. **SUBLIME LIGHTING LLC** will not be held liable for any costs arising from the customer possession or use of the equipment.

MISCELLANEOUS

1. Customer agrees that **SUBLIME LIGHTING LLC** shall not be held liable for personal injuries or damage sustained while using the equipment.
2. Customer agrees to keep officers, employees, or agents of **SUBLIME LIGHTING LLC** free and harmless from loss, damage, responsibility, or obligation sustained while the customer is in possession of the rented equipment.
3. Customer agrees to pay all attorney fees, court costs, and any other cost incurred by **SUBLIME LIGHTING LLC** in protecting its rights of property in this contract, or in suing customer for breach of this contract for the collection of due money.
4. Customer agrees to admit owner or representative to enter premises upon which rental equipment is stored for the purpose of checking its condition or for the purpose of repossession of the rented equipment if the terms of this contract are breached by the customer.
5. Customer agrees not to remove the rented equipment from the United States without written approval from **SUBLIME LIGHTING LLC**.
6. This contract cannot be altered or modified in any fashion except by a new written contract signed by both parties.
7. Nothing within this contract deems a joint venture or agency relationship between both parties.
